Who: Equal Employment Opportunity Counselors.

What: EEO counselors are the people trained and certified to handle your Equal Employment Opportunity Discrimination pre-complaint.

When: Contact the EEO Counselor within 45 days of the last discriminatory action or within 45 days of discovering a discriminatory action.

Why: The first step in an EEO discrimination case is the assignment of an EEO counselor. An EEO counselor is a neutral party that will assist you attempting to resolve your complaint at the lowest level.
